* **G.S.R. 691(E).**— The following draft of certain rules further to amend the Drugs and Cosmetics Rules, 1945 which the Central Government proposes to make, in exercise of the powers conferred by clause (a) of sub-section (2) of section 33-N of the Drugs and Cosmetics Act 1940 (23 of 1940), is hereby published as required by the said Section for the information of all persons likely to be affected thereby and a notice is hereby given that the said draft rules will be taken into consideration after the expiry of a period of thirty days from the date on which copies of the Official Gazette in which this notification is published, are made available to the public;

Any objection and suggestion, which may be received from any person with respect to the said draft rules within the period specified above will be taken into consideration by the Central Government.

DRAFT RULES

- (1) These rules may be called the **Drugs and Cosmetics (Amendment) Rules, 2005**.
- (2) They shall come into force on the date of their publication in the Official Gazette.

In the Drug and Cosmetics Rules, 1945;

after rule 161A, the following rule shall be added, namely:-

"161B: - The date of expiry of Ayurveda, Siddha and Unani (ASU) medicines shall be conspicuously displayed on the label of container or package of an Ayurvedic, Siddhas and Unani drugs, after which they shall not be in circulation. Shelf-life for Ayurveda, Siddha & Unani (ASU) medicines shall be as follows:
